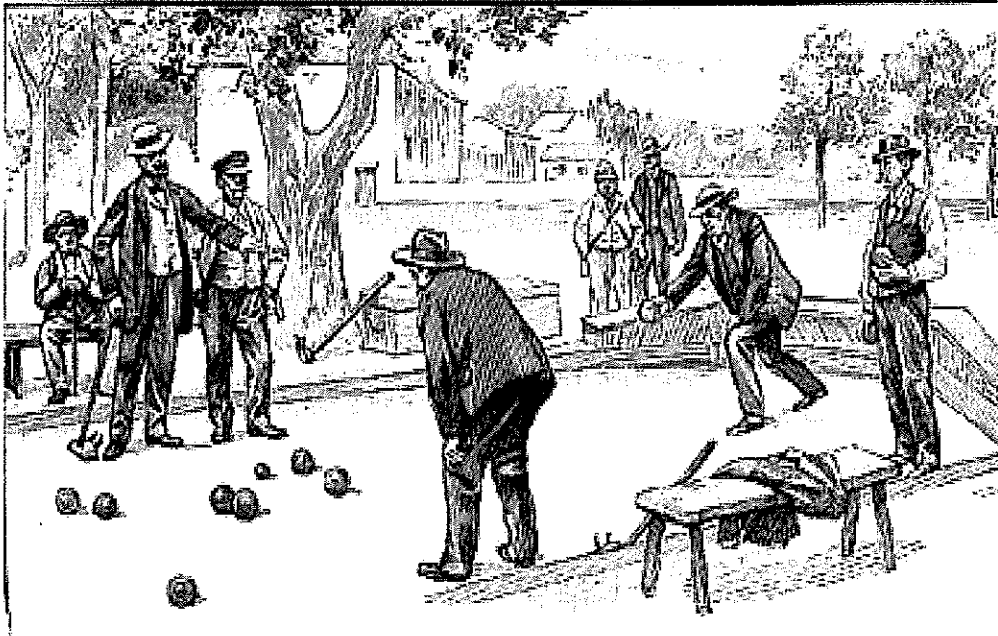
Resumes April 4

Timberlake Bocce League

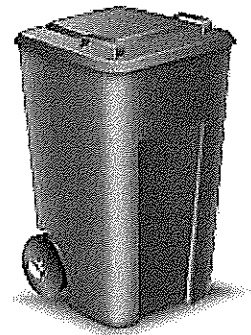

TIMBERLAKE COUNCIL MEETING

March 18, 2014

Mayor Cattani opened the meeting with the pledge to the flag at 7:30 PM. After the public portion Mayor Cattani asked for the roll call of officers. All were present.

The mayor asked for a motion to approve February 18, 2014 minutes.

Motion to approve: Stanton

Seconded: Zalar

Discussion to correct the minutes under Safety that Ken Zalar presented the information not Dennis Dicki. Corrections made

SAFETY

Ken Zalar discussed the recent alarms at the Dollar General store. The police are looking into this matter. The new stop signs are almost all put up. The police have been patrolling for speeding on East Shore and throughout the entire village. The police chief explained that the new patrol car is on schedule along with the grants for the computers for the patrol cars. We expect to receive the grants next month. We are looking into more grants from the state of Ohio for this year.

Ken Zalar and Mary Trepal started a survey, regarding the possibility of sidewalks on Lakeshore. They have gone to about a third of the homes. They will continue the survey to have it completed by the next council meeting with their results.

SEWERS

Jim Gasier reported that United Survey has started checking the sewers. 19 Owassa had a flooding problem in February due to a blocked catch basin. East Side Plumbing will clean out basin as soon as we get a break in the weather. There is a catch basin on East Shore by the police station that also has to be cleaned out.

COMMUNITY CENTER

Ritu Sharma reported that there are 10 new rentals. The freezer has been repaired. There are 4 Yoga sessions planned in the morning hours. The Village Club sponsored this activity.

The mayor reported that they are looking into putting the Times on the webpage along with the minutes from the council meetings. Nobody showed any interest in getting a microphone for the meetings. The mayor recommended talking louder and moving the chairs closer. As far as presenting an agenda for the

meetings, Timberlake does not have a secretarial staff as other municipalities for preparing this process. The mayor works off of his notes and each meeting is pretty much standard each month.

SERVICE

Mike Stanton reported that if the weather starts to cooperate the service department will transition from plowing to spring cleanup and maintenance. We only have one and a half truck loads of salt left for the season. A pallet of cold patch was purchased to start filling the potholes in the development. There are 50 bags @ 75# each. One bag normally fills one pothole. The worse holes will be filled first.

Regarding Resolution 2013-51, instead of doing a third reading today, Mike Stanton made a motion to withdraw this resolution for further review and resubmission at a later date.

The mayor would like to thank Mayor Morley of the City of Eastlake and Mayor Bondi of Willowick for agreeing to assist us, in case of another snow emergency, to allow us additional salt for the Village's roads. The mayor wanted to acknowledge the spirit of cooperation between the municipalities.

FINANCE

Dennis Dicki presented Resolution 2014-12 approving and direction payment of certain bills by the Village of Timberlake, and declaring an Emergency

PARKS AND RECREATION

Mary Trepal has enrolled in the Tree College program, which is a three day program that will be held the end of March. Mary will be meeting with Mike Stanton and the summer program director to start planning this years summer youth program.

The mayor reminded all that the Village Potluck will be held April 26th and the Easter Egg Hunt will be held on April 19th.

The mayor attended the annual Health Advisory Board for the County Health Department meeting last week. Our tax assessment is going to drop \$400.00 this year. In the last five years we have gone from \$6,600.00 to \$5,200.00.

The mayor also attended the annual state tax administration meeting. Nothing much is going to change this year but the state is pushing to consolidate municipalities for tax revenue and redirection of state funds. This should not affect municipalities that are all residential like the Village a Timberlake.

The mayor asked for a motion to adjourn meeting.
