TIMBERLAKE COUNCIL MEETING November 18, 2014

Mayor Cattani opened the meeting with the pledge to the flag at 7:35 PM. After the public portion, Mayor Cattani asked for the roll call of the officers. Ritu Sharma was not present and excused. Our Solicitor and Mrs. Stefaniak were also present.

The mayor asked for a motion to approve October 21, 2014 minutes

The mayor appointed Sam Santangelo III to the vacant position of Ken Zalar, who resigned for personal reasons. The mayor asked for a motion to approve.
Mary Trepal presented Resolution 2014-39 confirming the appointment of Sam Santangelo III to fill vacant position of councilman of the Village of Timberlake until December 31, 2017

The mayor swore in Sam Santangelo III to the vacant council position.

SAFETY

Chief Esser gave his monthly report that will be posted in the Village Times. Chief announced that the grant that was applied for, for a new police cruiser was denied. The village can reapply in 6 months which will give the department time to revamp the application as the state has changed the requirements for this application. The chief explained his new beard. November is "No Shave November" to raise awareness for cancer. Each officer is asking for pledges of \$25.00 per donation to be donated for this cause. The Taser body cameras have arrived and are currently being set up with the computers. The cameras should be up and on officers in about a week.

Mary would like to do a tree survey of the village. It would be done in sections. The last survey was done in 1994. She will be contacting Busy Bee Tree for an estimate of this survey.

Jim Gasier reported that bids are not back for the broken pipes in front of the Fox residence and the back yard of the Martic residence. Mr. Gasier would like to remind all residents to please keep storm sewer covers clear and free of leaves and debris. Mr. Gasier will be attending a free storm water training course November 19, 2014, that will be put on by Lake County Health District.

SERVICE

Mike Stanton reported the snowplow has been refurbished. The wiring harness was replaced and the blade on the plow at a cost of \$750.00. The first load of 20 tons of salt has been delivered of ODOT. Timberlake will on pay for the salt used.

**EXTRA! EXTRA!
READ ALL ABOUT IT!**

Lake Erie needs to go on a low salt diet. Control your salt usage this winter because when the snow melts, the leftover salt eventually flows into our creeks and storm drains, ending up in Lake Erie. Salt can be very harmful to plants and organisms that grow in and near our water ways. Help keep our water clean and free of salt by following the steps below.

- Chip and shovel away as much snow and ice as possible before applying salt products or alternative deicers.
- Save your salt. Try to use only as much salt as you need, and store your salt properly indoors or under cover.
- There is more than just salt. Do research into the alternative types of deicers on the market. They may perform differently at different temperatures and some are more environmentally friendly.
- Remember to follow the manufacturer's instructions. Deicers are meant to make the shoveling process a little easier by softening the ice, not to completely melt all the snow and ice.
