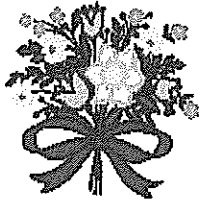

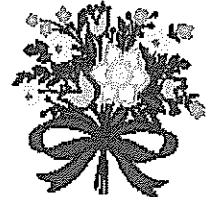

Tuesday, May 6 – Election Day

The village has 3 renewal levies on the ballot this Spring. Together, these levies generate roughly \$180,000 of operating funds for the village. The existing levies all expire at the end of 2014; these renewals will take effect in 2015, running for another five years, as past renewals have.

Reduce Runoff with a Rain Barrel

Any hard surface around your house can create runoff - from your roof to your driveway to your patio. If you collect this water and use it around your yard, you will help reduce the amount of water that flushes through a stream during a storm, and filter out some of the pollutants as well. You might even reduce your water utility bill in the summer.

Rain barrels are installed on downspouts around your house. They collect the rain that would otherwise empty into a storm drain or into a muddy spot in your yard. Up to 55 gallons of rainwater can be stored in a repurposed plastic food barrel from every April shower or July cloudburst. This water is free, and also free of utility water additives, such as chlorine and fluoride. Making it ideal to water your garden, lawn or landscaping.

Lake SWCD collaborates with Lake Metroparks to provide rain barrel construction workshops. Workshops for 2014 are scheduled for April 24, May 9, June 11 and August 14 at the Lake County Fairgrounds Natural Resources Building from 7-8pm; May 22 at Penitentiary Glen from 7-8pm; July 12 at Penitentiary Glen from 9-10 am.

You can also call the Lake SWCD office to make arrangements to pick up a pre-made barrel anytime during business hours. For more information, contact the Lake County Stormwater Management Department at 350-5900 or visit the website www.lakecountyohio.gov/smd.

TIMBERLAKE COUNCIL MEETING
April 15, 2014

Mayor Cattani opened the meeting with the pledge to the flag at 7:35 PM. After the public portion, Mayor Cattani asked for the roll call of the officers.

Present: Gasier, Sharma, Stanton, Trepal, Zalar

Absent: Dicki was absent and excused

Our Solicitor and Mrs. Stefaniak were also present

The mayor asked for a motion to approve March 18, 2014 minutes

Motion to approve: Sharma

Seconded: Stanton

In favor: Gasier, Sharma, Stanton, Trepal, Zalar

SAFETY

Ken Zalar had the chief talked about the restructuring of the police department. The Corporal position is vacant and the chief has no intentions at this point to fill this position at this time. The Chief is also looking into developing an Arson Investigator. It will be a pilot program at this time. There is a lot of grant funding programs for this position.

The Chief also announced that the Department of Homeland Security granted Timberlake \$7,000.00 that will be used to put computers and data terminal systems in the police vehicles.

Ken Zalar presented Resolution 2014-13, a resolution eliminating the position of Captain of the Village of Timberlake Police Department.

Mr. Zalar reported that all the new road signs are installed in the village.

SEWERS

Jim Gassier reported that several sewers were found to be filled with tree roots and the roots have been removed. Work will continue with the cameras and cleaning until project is complete. Dennis Dicki contacted Dave Miller of Lake County Storm Sewer Management. Mr. Miller said that he collects about \$5,000.00 per year from the county for Timberlake. The Village is due for \$80,000 to \$100,000. Mr. Miller would like to get with the Mayor, Mr. Formica, and Mr. Gasier, with regards to projected projects on the sewers in the village.

COMMUNITY CENTER

There are 10 rentals lined up for April. The requests for rentals for the rest of the year continue to come in. There was a fire inspection for the hall and everything passed.

The Mayor announced that the 3 renewal levies are up for election on May 6th. There are three levies which generate about \$180,000.00 which is about a third of our budget. Part of this money goes towards trash pick up. Most other municipalities, the residents have to pay for their own trash removal.

Also in this election is Issue 1 which is the state capital improvement levy which allows the state to issue bonds to get money for sewer and road and infrastructure improvements to counties and municipalities for long term projects. The last time Timberlake did the roads, the state gave Timberlake \$400,000.00. This funding also allowed Timberlake to do the lining project in our sanitary sewer lines.

FINANCE

Mr. Stanton presented resolution 2014-16, a resolution approving and directing payment of certain bills by the Village of Timberlake, and declaring an emergency.

Mr. Stanton presented Ordinance 2014-6, an ordinance amending ordinance 2014-5 line item appropriation B01, Street Maintenance and Repair, and declaring an emergency
Line Item Appropriation B01, Street Maintenance and Repair, currently at Twenty-Five Thousand Dollars (\$25,000.00) is hereby amended to reflect the balance of Thirty-Six Thousand Dollars (\$36,000.00)

Motion to waive three reading rule: Stanton

Mr. Stanton presented Ordinance 2014-7, an ordinance amending Ordinance 2014-5 line item appropriation B05, Enforcement and Education Police, and declaring an emergency.

Line Item Appropriation B05, Enforcement and Education Police, currently at One Hundred Fifty Dollars (\$150.00) is hereby amended to reflect the balance of Four Hundred Dollars (\$400.00)

SERVICE

Service will start picking up debris from roads and grass areas. The ground is still frozen about six inches below the surface so water in yards is not going down quickly. Our service person who comes home in the summer from college has informed us that he will be staying at school over the summer. Mr. Stanton has postings at the high school and Lakeland College for a part-time summer position.

Mr. Stanton also talked with Lakeland College's Dean about a possible internship were students could come and design an image for the village regarding landscaping at entrances and the grassy triangles. The advantage with this project is it would not cost the village anything.

Scott has been going through the village trying to patch the potholes.

Mr. Stanton presented Resolution 2014-17, a resolution confirming the appointment of Larry Formica to the Maintenance Code Board of Appeals. Said appointee shall serve on the Board of Appeals for three (3) years commencing May 1, 2014 through April 30, 2017.

All were in favor

Mr. Stanton presented Ordinance 2014-9, an ordinance amending Section 700.10, placement of containers for pick up of the codified ordinances of the Village of Timberlake, and declaring an emergency.

700.10 Placement and Storage of Trash Containers

- a) All rubbish, garbage, and trash containers/receptacles shall be stored out of sight from the public way.
- b) Notwithstanding Section (a), all rubbish, garbage and trash containers shall be placed on the curb at the tree lawn no sooner than 24 hours prior to the

scheduled rubbish, garbage, and trash collection, and shall be removed within 24 hours following such collection.

Mr. Stanton placed this ordinance on first reading as of 4/15/2014

Mr. Stanton presented Ordinance 2014-10, an ordinance amending Section 1260.10, side yards, of the code of ordinances for the Village of Timberlake, and declaring an emergency.

Section 1260.10, Side Yards, is hereby amended to read as follows:

In the Residence District, for every building, there shall be a side yard along each lot line other than a street line or rear line, the least dimension of which shall be five feet. The side yards herein provided for shall be open for their full required dimensions from the ground to the sky, unobstructed, except for the following provisions:

- a) ordinary projections of window sills, belt courses, window unit air conditioners, trees, landscaping, electric and gas meters and fence returns;
- b) central air conditioning units, heating and air conditioning pumps and generators installed prior to the enactment of this ordinance until such time any such item is to be replaced.

Mr. Stanton placed this ordinance of first reading as of 4/15/2014

The Planning Commission will have a meeting May 12, 2014 at 7:00 PM

PARKS AND RECREATION

Mrs. Trepal went to tree school and graduated. She presented her certificate. It was three full days at Holden Arboretum. She will be putting websites up for the community on how to inspect trees for problems.

Mrs. Trepal will be having a trees, parks, and recreation meeting on May 15, 2014 at 7:00 PM.

Mrs. Trepal inspected all the recreation areas and everything seems in good shape. Mulch is needed in a few areas. The sign at the beach needs to be repainted.

The summer program will be from June 9th through July 4th. The two teachers running the program are certified elementary teachers. Mary still needs a few volunteers to help with this program. Forms and registration have been posted on the Village website.

The Mayor asked for a motion to adjourn.

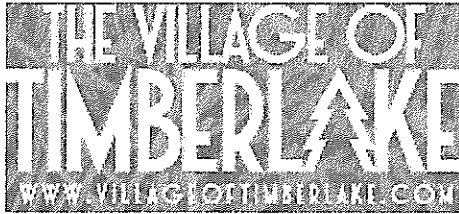
